Course of one year duration, from the academic session 2005-2006 with an annual intake of 100 (one hundred) students subject to fulfillment of the following:
 - a) The institution will ensure that HOD and at least 07 (seven) faculty members qualified as per NCTE norms and duly approved by the affiliating University are in position on regular basis for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month: from the commencement of the course.

The institution shall ensure a separate Department of Teacher Education... with separate building, hostel and other necessary infrastructural and instructional facilities.

d) The institution shall ensure financial management with a separate budget for the Teacher Training Department. The Department of Teacher Education shall shift to its own building having separate campus within a period of 3 years.

The institution shall comply with the various other norms and standards;
